By installing or downloading this font, you are agreeing to be bound by the terms of this Agreement.

1. Allowed uses

You may use the licensed font free for personal, non-commercial projects to create images on any surface including but not limited to computer screens, paper, web pages, photographs, movie credits, printed material, T-shirts etc. providing they aren't monetized via other sources or means e.g. a website that generates income via banner ads, google adsense, etc

For commercial uses - uses primarily intended for or directed toward commercial advantage or private monetary compensation – you are required to purchase a commercial license from <http://www.practiquefont.com/> per commercial use. That is you need to purchase a new commercial licence per commercial use (project) the font is used within. Failing to do so will result in legal action.

2. Third parties

You may provide the font to a graphic designer, printer or other service bureau that is working on your behalf only if they agree to use the font exclusively for your work, agree to the terms of this license, and retain no copies of the font on completion of the work.

You may not provide, distribute or make the font accessible to any other third parties without the express written consent of Blindfrog Industries contactable at license@blindfrogindustries.com

3. Embedding

You may embed the licensed fonts into any document you send to third parties. Such documents may be viewed and printed (but not edited) by the recipients.

For web embedding, you can use WOFF, @font-face, SIFR, Cufón or Embedded Open Type (EOT). You can use third-party software to convert @font-face formats mentioned above. For commercial web embedding you may display the font on an unlimited number of web pages, within one (1) web domain, upon purchase of a commercial license. For multiple domains, you need to purchase a commercial license per domain.

You may not under any circumstances embed the licensed fonts into software or hardware products in which the fonts will be used by the purchasers of such products. Such use requires a special commercial license, attainable by contacting Blindfrog Industries
